RIDERS RELEASE OF LIABILITY, WAIVER OF LEGAL RIGHTS AND ASSUMPTION OF RISK

In consideration for the opportunity for event participation and utilization of the riding park, recreational facilities, and premises of Cadillac Ranch Motorsports Inc. (CRMI), and Larry and Holly Mahan, and their respective affiliates in furtherance of the sport of dirt bike riding and driving, motor sports racing and driving, motor sports, all spectators and related activities, (hereinafter collectively called "motor sports").

I hereby understand and agree to this Release of Liability, Waiver of Legal Rights and Assumption of Risk and to the terms hereof as follows:

1. I acknowledge that Motor sports is an action sport and recreational activity involving travel in three dimensions and that such activity is subject to mishap and even injury to or the death of participants. I understand I may suffer broken bones, internal injuries, paralysis, or fatal injury, as well as the loss of or damage to personal property while participating in Motor sports. **(Initial here _____)**.
2. I hereby RELEASE AND DISCHARGE CRMI, Larry and Holly Mahan, and all related parties, event volunteers, company offices, directors, elected officials, agents, employees, and owners of equipment and the land used for motor sports activities (hereinafter collectively referred to as "Released Parties"), from any and all liability, claims, demands or causes of action that I or my representatives may hereafter have for injuries, loss of life, and all other forms of damages arising out of my participation in Motor sports activities, including, but not limited to, losses CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES. **(Initial here _____)**.
3. I understand and acknowledge that motor sports riding and racing activities have inherent dangers that no amount of care, caution, instruction, or expertise can eliminate and I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY OR OTHER FORMS OF DAMAGES SUSTAINED WHILE PARTICIPATING IN MOTOR SPORTS ACTIVITIES WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES. **(Initial here _____)**.
4. I further agree that I WILL NOT SUE OR OTHERWISE MAKE A CLAIM against the Released Parties for damages or other losses sustained as a result of my participation in CRMI activities. **(Initial here _____)**.
5. I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgments, and costs, including attorney's fees, incurred in connection with any action brought against them, jointly or severally, as a result of my participation in CRMI activities. **(Initial here _____)**.
6. I will take full responsibility for, and hold harmless Released Parties for any injury, property damage, or death that I may suffer or inflict upon others or their property as a result of my engaging in CRMI activities. **(Initial here _____)**.
7. I agree that I will operate the said equipment in a reasonable and safe manner so as not to endanger the lives of persons or property of any individual. **(Initial here _____)**.
8. I have read and understand the above and acknowledge that the same constitutes a release of liability and a waiver of my legal rights and also acknowledgement of the assumption of liability by me of all risks arising out of my engaging in CRMI activities. **(Initial here _____)**.
9. I further represent that this Release of Liability, Waiver of Legal Rights and Assumption of Risk shall continue in full force and effect for so long as I engage in CRMI activities which are in any way connected to or with the Released Parties. **(Initial here _____)**.
10. I further represent that I am at least 18 years of age, or that as the parent or (adult) legal guardian. I waive and release any and all legal rights that may accrue to me, to my minor child, or to the minor child for whom I am (adult) legal guardian, as the result of any injury or damage that my minor child, the minor child for whom I am (adult) legal guardian, or I may suffer while engaging in CRMI activities. **(Initial here _____)**.
11. I hereby expressly recognize that this Release of Liability, Waiver of Legal Rights and Assumption of Risks is a contract pursuant to which I have released any and all claims against the Released Parties resulting from participation in CRMI activities including

any claims related to the negligence of the Released Parties by any of the undersigned. (Initial here _____).

12. Photo and Productions Rights: I agree that all rights, property, and interest in any photograph, broadcast by radio, television, motion pictures, home video productions or by any other means or media (including any transcriptions of any such broadcast) of any CRMI activities, as well as any and all receipts there-from, belong to CRMI for its exclusive and unlimited use. I further agree that CRMI or its assigns, on a non-exclusive basis, may use my name and pictures (including pictures of my racing equipment and pictures taken during CRMI activities) for any purpose and in any media including, but not limited to, television, motion pictures, advertising, trade, home video production or any lawful purpose, and I waive any right to inspect or proof the finished version. I also understand that CRMI may, from time to time, engage a sports marketing firm to, among other things, promote the image of the CRMI activities, and I agree to cooperate with CRMI and its sports marketing firm in such efforts.
